There are many different types of performances held throughout each day of the fair and we welcome a variety of acts. **Please keep in mind the following KEY information:**

- Your proposed act, including any props, images, attire, etc. MUST be family-friendly and appropriate for all ages.
- If the application is not filled out in its entirety, then your application will not be considered. This includes rates. "See attached" will not be accepted on the application. Applications are not kept on file. A new application must be submitted each year.
- Applications are reviewed the winter prior to the Fair year and are considered in order by the date the Fair Office receives them. For bands, priority is given to local and talented artists willing to play complimentary or for Fair ticket exchange.
- Scheduling of acts occurs in early spring and may continue through May 31, 2025; however, **regret letters will not be sent.** The email address and contact person you fill out in the form below will be contacted via email if you are selected to perform.
- Due to the high number of applications received, Fair staff is unable to give updates on the status of your application. If your act is chosen, you will be notified by the end of May 2025.
- Professional sound, lights and staging are provided by the Fair for Bands ONLY. Grounds acts are to be self-sufficient and provide all equipment necessary to perform.
