Fair season is here! Each year the Cabarrus County Fair hosts approximately 60,000 people during the 9 days of the fair.

Our Mission

Rooted in agriculture and fueled by community spirit, the Cabarrus County Fair showcases rodeo thrills, livestock shows, competitive exhibits, rides, food, and fun. Our mission is to create lasting memories for the whole family.

Background

The Cabarrus County Agricultural Fair was organized in 1953. For forty-nine years the fairs were held at the intersection of Cabarrus Avenue and Union Cemetery Road. In December 2000, the Cabarrus County Board of Commissioners agreed to assume responsibility for managing the annual fair in exchange for ownership of the original fairgrounds. The county purchased a 70-acre parcel located at Highway 49 and Old Airport Road in Concord; and in June 2001, ground was broken on the Cabarrus Arena and Events Center. The 50th Annual Cabarrus County Fair was held at the new facility in 2001. For the first time in its history, the Fair was canceled in 2020 and 2021 due to the COVID-19 pandemic public health concerns. In 2025 the Cabarrus County Fair began a new chapter under new leadership. We remain dedicated to honoring our agricultural traditions, while continuing to grow, improve, and serve our community.

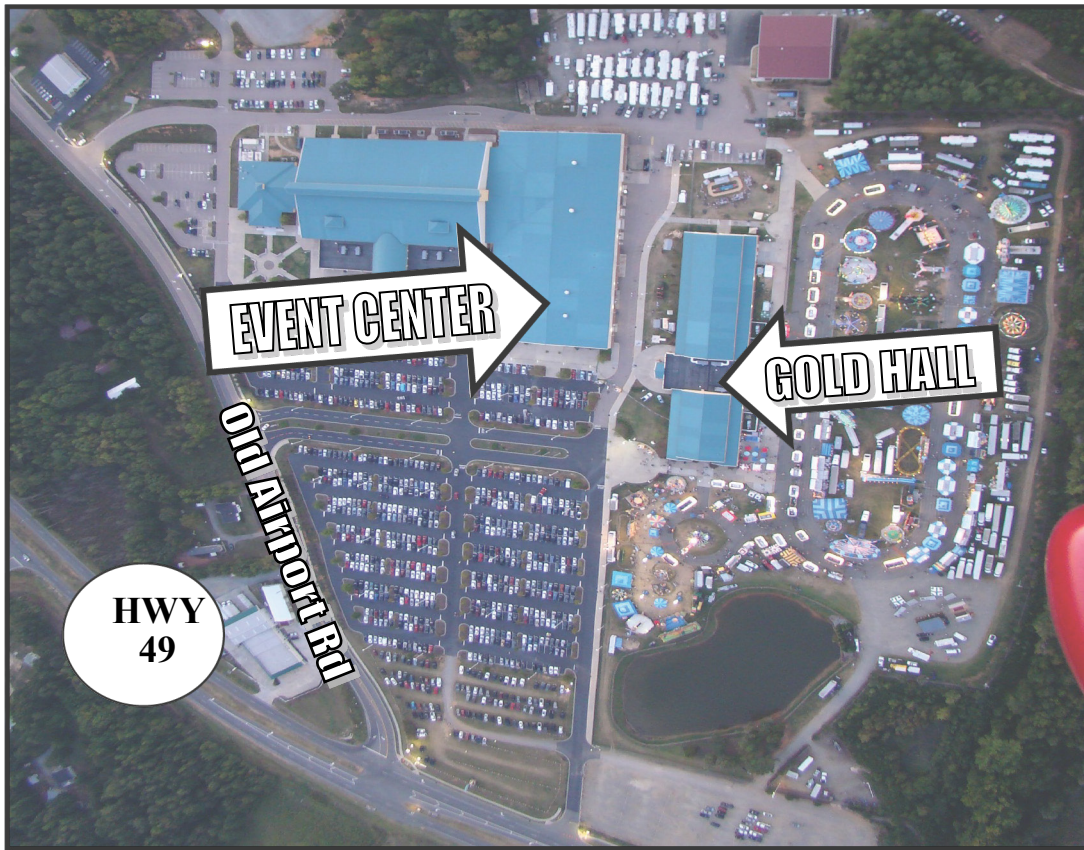

- All entries should be produced within the last year (after September 13th, 2025)
- **Use the Official Competitive Exhibits Entry Form for all exhibit entries.** Livestock, poultry and rabbit entries must use the Livestock & Equine Official Entry Form.

 - If your item is larger than this, contact the Fair Office ahead of submitting your entry form to confirm if the fair will be able to accept it or not.
- Quilts, Afghans, etc. may be displayed folded to meet size specifications.
- All drawings, paintings, photographs, etc. must be framed or mounted to support proper display.

- ONLY ONE ENTRY PER EXHIBITOR PER CLASS MAY BE ENTERED (unless otherwise specified within the department rules.)
- No one under the age of 5 may enter.

- Exhibitors must be able to safely handle their animal.
- Exhibitors ages 5-8 may be accompanied by an adult to ensure the safety of both the animals and the exhibitors.
- Good sportsmanship and respectful behavior are expected at all times.
- All entries are subject to current North Carolina health regulations in effect at the time of the fair.
- All animals will be examined by an on-site, licensed veterinarian, contracted by the fair, prior to admission to the show area. Please see individual show pages for animal specific health rules and regulations.

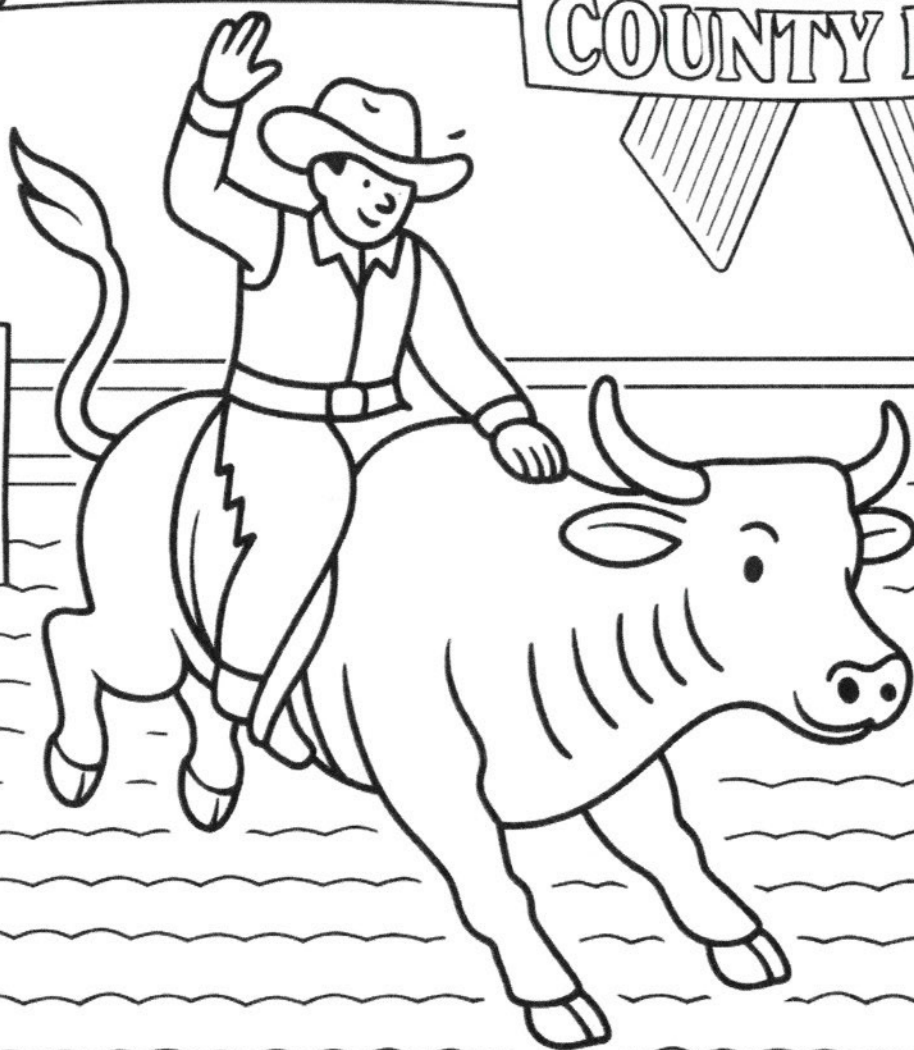
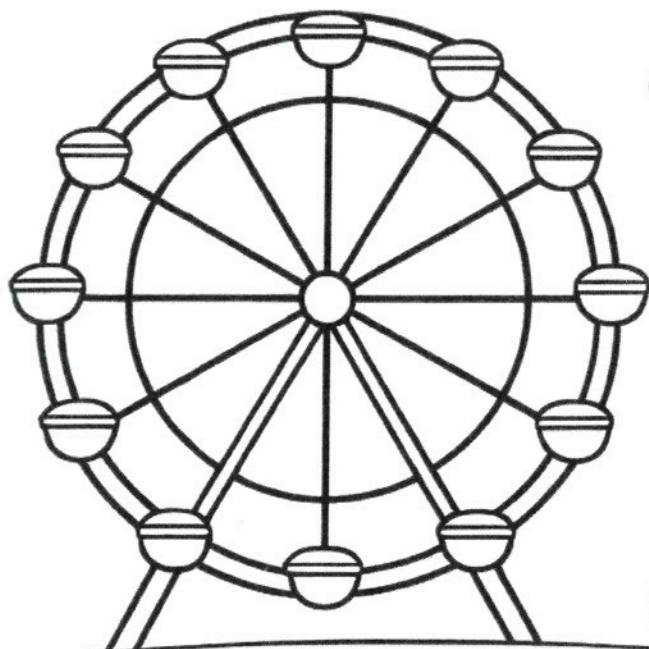

YOUTH TRACTOR SAFETY & DRIVING COMPETITION

Show Date: Saturday September 19th, 2026 at 11:00 am

Location: Main Arena



Awards will be presented to the 1st, 2nd & 3rd place winners in each division.

Rules & Regulations:

- Competition is limited to 10 contestants per division. If one division does not fill, available spots may be filled by contestants from the other division. **Competition is limited to 20 total participants.**
- If more than 20 entries are received, priority will be given to residents of Cabarrus County. Any remaining openings will be filled based on the order in which entries are received.
- Middle School Division- Ages 11-13.
- High School Division- Ages 14-18.
- Arena will open at 10:00 am to allow contestants to familiarize themselves with the course layout and equipment.
- Participants will be judged on their knowledge and demonstration of safety practices and skills in the operation of a tractor with a two-wheeled trailer through a designated obstacle course.
- The North Carolina FFA Association Tractor Driving Score Card will be used to score participants performance.
- The North Carolina FFA Association Tractor Driving Course Outline will be used as a reference for the course set-up.
- The lowest score is the winner.
- Tractor and trailer will be provided.
- Contestants must demonstrate proper mounting, starting, and shutdown procedures.
- Judges may ask safety-related questions prior to operation.
- Course will include straight line backing, turning within boundaries, precision parking. Contestant will be timed.
- Emphasis is placed on safety, accuracy, and smooth operation- not speed.
- Trailer will remain hooked to the tractor at all times. Contestants will NOT be required to hook up to or unhook the trailer as part of the competition.
- Points are deducted for seat belt not used, hitting markers, unsafe speed, poor throttle control, multiple attempts at backing the trailer, excessive speed. (Please review score card for a complete list of judging criteria and scoring categories)
- Participants must follow all instructions from judges and event staff.
- Disrespectful or unsafe behavior will result in disqualification.
- The judges reserve the right to disqualify any participant at their sole discretion if they determine that the operation or conduct presents a safety risk to the participant, spectators, other participants, or equipment. All decisions regarding safety are final.
- There will be a 10 minute maximum time limit per contestant.
- All entries are due by August 24th, 2026 at 4:00 pm.

There will be a Division Winner in each age division, as well as a Community Service Queen. All Age Division Winners, except Miss, will receive a tiara, sash, and Pageant Shirt, and will be asked to walk throughout the fair that evening with Tiara/Crown, Sash and T-Shirt on. Miss Division will receive a crown, sash, and Pageant Shirt.

A Community Service Queen will be crowned as the contestant that brings in the highest number of snack pack items for our featured non-profit, 1Can, Inc. 1Can, Inc distribute snack packs several times each school year to Cabarrus County Schools and Kannapolis City Schools. Items that are in each snack pack are Goldfish, Fruit Snacks, and Juice Box. These snack packs are little positive notes for those children that otherwise wouldn't have anything. All items need to be dropped off prior to registration on the day of the pageant, and each contestant will be given confirmation of the total number of the items that are counted towards their name.

Phases of Competition:

Competition will consist of an on-stage introduction that is judged based on community service, community involvement, stage presence and personality. Natural hair, light make-up (for older girls) and Best Denim & Diamonds Theme wear is appropriate. All participants must be in good academic standing and have no disciplinary issues on record.

1. On stage introduction (community service, personality) – 50% They should come across naturally and speak with personality. Their community involvement could be related to school, church or a charity that they support in their community.
2. Walking across the stage (poise, confidence, stage presence) – 50%
 - Attire is to be a form of our Rodeo Theme this year, which is "Denim & Diamonds"!
 - Natural hair and light make-up. Hair can be rolled, curled, etc. Outdoor pageant, and it will be hot!

The judges will be told that this is a natural pageant so please have natural hair and make-up.

This simply means not to overdo it. Hair and make-up can be like going to a school dance (not prom).

Registration is at 1:30. At that time, all Snack Pack Items will be tallied, and finalized for competition. Each contestant will receive their contestant number at registration. Contestants will pin their number on their left side of their theme wear, to be visible to judges.

When the competition begins, each age division will be called up and that group will go up on the stage all at one time as a collective line up. They will then go off stage and come back on individually as the emcee introduces you. You will simply step up onto the stage and introduce yourself in the microphone. Keep it short and simple and remember that the judges are looking for personality. You will then walk in a standard "T" formation as the emcee talks about what is on your paper. We will show this walking pattern prior to the competition. Once you have walked, the emcee will thank you by stating, "Thank you Contestant Number...". You will then walk off stage. Once each division is completed, there will be a short intermission so the judges can tally the scores.

Thank you so much for being a part of this year's "Denim & Diamonds" pageant and best of luck to each contestant.
